

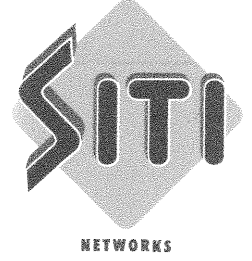



Had these expenses been disclosed on net basis, the 'Revenue from Operations' and the 'Pay channel, carriage sharing and related costs' each would have been lower by ₹ 9,316.9 lacs, ₹ 9,204.2 lacs and ₹ 18,521.1 lacs for the quarter ended June 30, 2020, and for quarter and six months ended September 30, 2020 in the standalone financial results, and ₹ 19,093.1 lacs, ₹ 19,332.2 lacs and ₹ 38,425.3 lacs for the quarter ended June 30, 2020, and for quarter and six months ended September 30, 2020 in the consolidated financial results, respectively, though there would have been no impact on the net loss for the quarter and period then ended. The management is in process of evaluating the aforesaid presentation in light of generally accepted accounting principles, including Ind AS-115, 'Revenue from contracts with customers' and industry practices.
